**ENACTED IN 1935, THESE LAWS

ALSO KNOWN AS THE NIGHT OF  
BROKEN GLASS**

**THIS TITLE IS GIVEN BY YAD  
VASHEM, THE HOLOCAUST  
MEMORIAL IN ISRAEL, TO  
NON-JEWS WHO RISKED THEIR  
LIVES TO SAVE JEWS DURING  
THE HOLOCAUST.**

**THIS JEWISH GIRL DOCUMENTED HER EXPERIENCES IN HIDING DURING THE HOLOCAUST IN HER FAMOUS DIARY. SHE DIED IN THE BERGEN-BELSEN CONCENTRATION CAMP, BUT HER DIARY SURVIVES AS A POIGNANT ACCOUNT OF THE HOLOCAUST.**
